

Harley's Haven Dog Rescue is raffling off a classic 1967 Ford Thunderbird to raise funds for our dog rescue and a portion of the fund raised will be donated to our friends at It's a Ruff Life Rescue. rescue. The drawing will take place on December 22, 2018 at 5:00 PM. The drawing will take place at Hair Studio 1208 in Quakertown, PA 18951.

Tickets are available for a donation of \$50 for each ticket, and you need not be present to win. No more than 500 tickets will be made available. In the event fewer than 200 donations of \$50 per donation are received by 12:00 PM on December 22, 2018, the raffle will be held as scheduled, but the Winner will not receive the car, but will receive a sum equal to 50% of the donations actually received, less 10% to be retained by the Rescue to cover expenses, but not to exceed \$4,500. For example, in the event 200 donations of \$50 per donation are received, the Winner would receive \$4,500 calculated as follows $\$10,000 \times .5 \times .9 = \$4,500$. The calculation of the donations actually received and the amount to be awarded shall be based solely on the Rescue's accounting, which shall be final and conclusive with respect to the Winner.

Tickets are **not transferable**. Only one eligible person may be entered in the contest per ticket sold. If the name of more than one person is submitted, and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner.
